# ONLINE PRIVACY POLICY AGREEMENT

#### Why We Collect Information and For How Long

We are collecting your data for several reasons:

- To contact you to fill out surveys or participate in other types of market research, when we have your consent to do so;

The data we collect from you will be stored for no longer than necessary. The length of time we retain said information will be determined based upon the following criteria: the length of time your personal information remains relevant; the length of time it is reasonable to keep records to demonstrate that we have fulfilled our duties and obligations; any limitation periods within which claims might be made; any retention periods prescribed by law or recommended by regulators, professional bodies or associations; the type of contract we have with you, the existence of your consent, and our legitimate interest in keeping such information as stated in this Policy.

## **Use of Information Collected**

National Hispanic Medical Association does not now, nor will it in the future, sell, rent or lease any of its customer lists and/or names to any third parties.

National Hispanic Medical Association may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. At times, we may find it necessary to use personally identifiable information as a means to keep you informed of other possible products and/or services that may be available to you from www.nhmamd.org and its subsidiaries.

National Hispanic Medical Association and its subsidiaries may also be in contact with you with regards to completing surveys and/or research questionnaires related to your opinion of current or potential future services that may be offered.

National Hispanic Medical Association uses various third-party social media features including but not limited to Facebook, X, Instagram, LinkedIn, YouTube and other interactive programs. These may collect your IP address and require cookies to work properly. These

services are governed by the privacy policies of the providers and are not within National Hispanic Medical Association's control.

# **Disclosure of Information**

National Hispanic Medical Association may not use or disclose the information provided by you except under the following circumstances:

- as necessary to maintain, safeguard and preserve all the rights and property of National Hispanic Medical Association.

## **Notice to European Union Users**

National Hispanic Medical Association's operations are located primarily in the United States. #### Security

are kept in a secure environment. This is all done to prevent any loss, misuse, unauthorized access, disclosure or modification of the user's personal information under our control.

The company also uses Secure Socket Layer (SSL) for authentication and private communications to build users' trust and confidence in the internet and website use by providing simple and secure access and communication of credit card and personal information. In addition, National Hispanic Medical Association is a licensee of TRUSTe. The website is also secured by VeriSign.
