



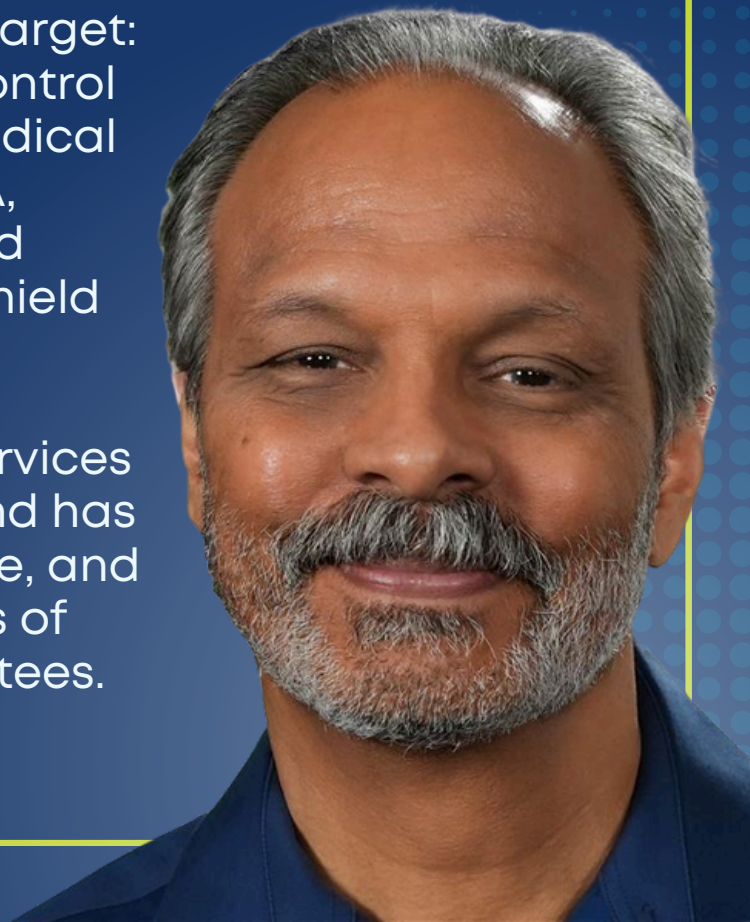

He served as Principal Investigator (PI) from 2020 to 2024 of the National Hypertension Control Initiative (NHCI), an agreement with the U.S. Department of Health and Human Services (HHS) Office of Minority Health (OMH) and the Health Resources and Services Administration (HRSA).

He is the AHA clinical lead for Target: BPTM, a joint blood pressure control initiative with the American Medical Association. Before joining AHA, he served as Vice President and CMO for Blue Cross and Blue Shield of Texas. Dr. Sanchez was Commissioner of the Texas Department of State Health Services from 2004 to 2006. He serves and has served on numerous local, state, and national health-related boards of directors and advisory committees.

Penn State College of Medicine*

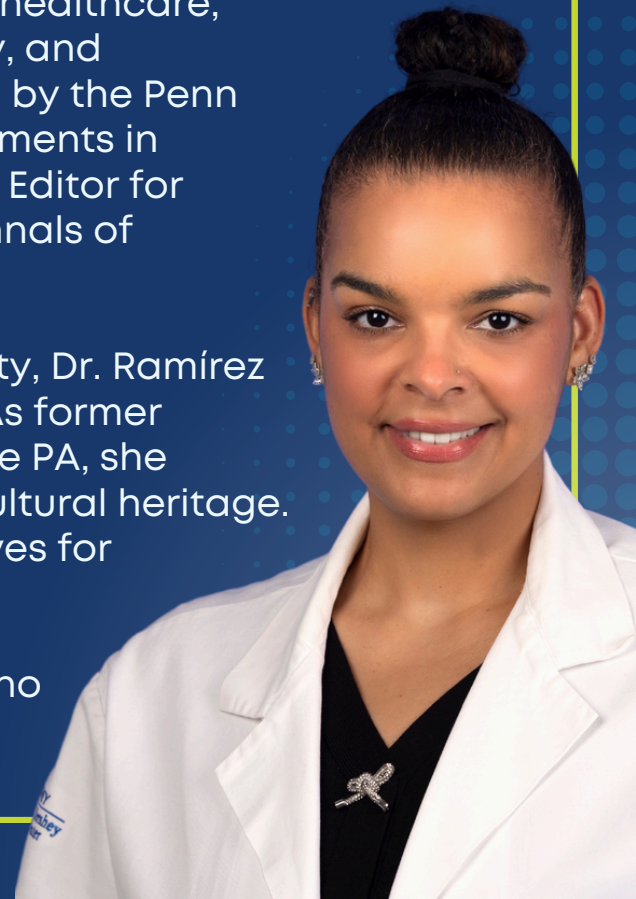
*Family Medicine Physician, Penn State Health*

Dr. Ramírez is a family medicine physician at Penn State Health and founder and president of the Pennsylvania chapter of the NHMA. She earned her medical degree from Ross University School of Medicine, completed a family medicine residency at MedStar Franklin Square Medical Center, and an obstetrics fellowship at the University of Illinois College of Medicine in Peoria. Her broad scope of practice includes pediatric and adult care, as well as obstetric care and deliveries.

A recognized educator, researcher, and author, Dr. Ramírez is an invited speaker on culturally responsive healthcare, social determinants of health, health equity, and reproductive justice. She has been honored by the Penn State College of Medicine's Exceptional Moments in Teaching program and serves as Associate Editor for MedEdPORTAL and peer reviewer for the Annals of Family Medicine.

A trusted advocate for the Latino community, Dr. Ramírez has led impactful public health initiatives. As former President and Director of Estamos Unidos de PA, she championed programs promoting Latino cultural heritage. She has advised cancer-prevention initiatives for Latino communities through the Penn State Cancer Institute's Hispanic/Latino Cancer Community Advisory Board and co-led Latino Connection's CATE initiative, delivering 2,000+ COVID-19 vaccinations statewide.
